The Charitable Giving Coalition (CGC) is dedicated to protecting and enhancing a century-old American tradition – the charitable deduction – that encourages Americans to give more to charity than they otherwise would. Formed in 2009, the CGC is made up of a broad cross-section of nonprofit organizations across the country, including individual charities, faith-based organizations, private and community foundations and their grantees, as well as the associations and umbrella groups that serve the charitable sector.

The charitable deduction is a vital and unique incentive that encourages a selfless act. A hallmark of American democracy is the tendency of its citizens to associate and help each other through a variety of generous acts, and charitable gifts are essential to maintaining that vibrant civil society.

The Coalition is making a strong case about the importance of the charitable tax deduction and is committed to working with policymakers to protect and enhance the charitable deduction for all Americans.
